#### **READ Foundation (Introduction):**

#### **Scope of Work & Specifications of Office Furniture and Workstations:**

Scope of Work includes supply, installation and commissioning of Office Furniture and Workstations as per specifications and pictures attached as "Annexure-D" with this Tender Document at READ Foundation (Head Office) Building, Near Koral Interchange, Islamabad.

#### **Instruction to Bidders:**

- 1. The bidding procedure of Single Stage-two envelope procedure will be followed in this Tender Document. A single package containing two separate envelopes clearly marked "Technical Bid" and "Financial Bid" shall be submitted.
- **2.** Bids must include the complete address of bidder's office with name, mailing address and telephone number of the person, the company should be contacted regarding the bid.
- **3.** Bids must be signed by a company officer empowered to bind the executing agency.
- **4.** Bidders must understand that their qualification for consideration for award of the contract depends upon their ability to deliver all services as illustrated in "Scope of Work / Annexure-D".

#### 5. Technical Bid duly filled shall contain:

- i. Company's Profile;
- ii. Copies of Income Tax & Sales Tax Registration Certificates.
- iii. Complete details of similar projects completed during the last 3 years. **Documentary** evidence in the form of Purchase/Work Order, Agreement or Experience Certificate is mandatory.
- iv. Complete details of similar projects in hand. Documentary evidence in the form of Purchase/Work Order or Agreement is mandatory.
- v. List of Workshops facilities in Pakistan.
- vi. Undertaking on Stamp Paper of Rs.100/- or above that the company/firm have never been Black listed by any Govt. department, private organization, NGOs' nor they are involved in any litigation with any department. Failure to provide this undertaking will result in the REJECTION of the Bid.

- 6. Financial Bid duly filled in format given at "Annexure-A" shall contain:
  - i. Rates of the required items as per specifications (inclusive of all applicable Govt. taxes).
  - ii. Bid security equals to 3% of the total project cost in the form of Pay Order/Demand Draft issued by a Scheduled Bank of Pakistan in favour of "READ Foundation". Bid submitted without bid security shall be rejected being non-responsive.

### **Terms and Conditions:**

- 1. Bid validity will be counted from the last date of its submission (mentioned below). While comparing the offers, if the procuring entity observes that a bidder has charged an incorrect tax ratio, it reserves the right to rectify it. The bidder would be required to conduct the detailed visit of the premises to determine the exact size of the required furniture before submission of the bid.
- 2. The bid security of the successful bidder will be retained as a "Performance Guarantee" until successful delivery of all items and completion of project. Bids security of the unsuccessful bidders will be released and can be collected from the office of the "Procurement Department" within ten (10) calendar days upon award of contract to the successful bidder.
- **3.** READ Foundation will not accept, pay or bear the cost of any substandard material, workmanship of work and the Supplier must ensure that all items delivered shall meet the specified requirements and adhere to international standards. The supplier must make arrangements for disposal of trash generated during fixation and timely removal of the debris from the site.
- **4.** The Supplier shall be responsible for any damage that may occur during the course of execution of work and shall be liable for its rectification / repair in accordance with the restoration of its originality.
- **5.** Boarding, lodging, loading, unloading and transportation will be responsibility of the bidding firm on each respective floor.
- 6. The successful bidder will have to provide a work schedule of start and completion dates and the order in which the delivery and work will be completed at site. In case of delay (not due to any justified reason, duly accepted by purchaser), a penalty of 1% of the total contract amount will be charged for every seven (07) days of delay beyond the agreed-upon project completion date.
- 7. The unit price quoted by the bidder shall remain firm and fixed during the bidder's performance of the contract and not subject to variation on any account including any price escalation, currency exchange rates, increase and decrease of taxes, levies and duties by the Government.
- **8.** Any advance requested by the bidder will be against either a Bank Guarantee, issued by Scheduled Bank of Pakistan (with minimum six months validity) or a Pay Order of equal amount (cross cheque is not acceptable).
- **9.** The Supplier shall be responsible for any damage of the equipment / material during transportation to site, storage and installation until satisfactory handing over to the Client. It will be the Supplier's entire

responsibility to ensure that all necessary precautions are taken during transportation to avoid damage to any of the equipment. The Supplier shall replace any damaged equipment/materials at his own cost. The furniture shall remain at risk and in the physical custody of the bidder until the delivery, installation and commissioning is successfully completed at site.

- 10. READ Foundation or its representatives accept no liability, expressed or implied, for any damages that may occur or may be incurred before and during the period of execution of work. Furthermore, READ Foundation or its representatives accept no liability for bodily harm, injury or death that might come about as a result of the implementation of the project. The successful bidder shall bear responsibility for the safety of his employees, labour, during work execution within project site area.
- 11. A bidder shall submit only one bid, in the same bidding process, either individually as a bidder or as a member in a joint venture or any similar arrangement. Collusion between the firms is strictly prohibited. Any firm / group of firms found involved in creating a cartel or any other collusion arrangement against the interest of the procuring entity, will be blacklisted and debarred.
- 12. The successful bidder must provide a 3D view Presentation showing their design theme for all items (Part A) to the Purchaser before signing the Contract. Further, the successful bidder shall submit the applicable samples after incorporating any changes suggested by the Purchaser, within ten (10) days of receiving approval for the 3D view presentation.
- 13. The bidder may after its submission withdraw its bid prior to the expiry of the deadline prescribed for submission of bids. Withdrawn bids will be returned unopened to the bidders.
- **14.** Usage of correction fluid & corrections are strictly prohibited unless duly initiated. Any erasing/cutting etc. appearing on the bid, must be properly signed by the person signing the Tender.
- 15. The Purchaser reserves the right to alter quantities or delete some items specified in this Tender Document, when awarding contract to successful bidder. The Purchaser shall be under no obligation to accept the lowest or any other offer received in response to this Tender Notice and shall be entitled to reject any or all bids without assigning any reason at any stage.
- **16.** A bidder's failure to submit its bid prior to the deadline will cause the bid to be disqualified. Late bids, conditional quotations or amendments will not be accepted for evaluation.
- 17. Payment will be made through cross cheque / IBFT after deduction of applicable Govt. taxes.
- **18.** Each paper of the bid document alongwith this Tender Document shall be stamped and signed by the authorized Signatory of the firm/company.
- 19. Sealed bids must be received latest by Monday, 01<sup>st</sup> September 2025 before 11:00 a.m via courier service, postmail or by hand and will be opened on the same day at 11:30 a.m (afternoon) in the presence of bidder's representative who may wish to attend. Representatives of the bidders who choose to

attend shall sign the "Attendance Sheet". Kindly mention "Tender Reference Number" at top left corner of the envelope.

#### **Cost of Bidding:**

The bidder shall bear all costs associated with the preparation and submission of its bid and READ Foundation will in no case be responsible or liable to these costs, regardless of the conduct or outcome of the bidding process.

#### **Amendment of Bidding Documents:**

At any time, prior to the deadline for submission of bids, READ Foundation may, for any reason, whether at his own initiative or in response to a clarification requested by an interested bidder, modify the Bidding Documents by issuing "ADDENDUM". Any addendum thus issued shall be part of the Bidding Documents and shall be available to download on READ Foundation's official website. To afford interested bidders reasonable time in which to take an addendum into account in preparing their Bids, the READ foundation may at its discretion extend the deadline for submission of Bids.

## **Contract Amendment:**

READ Foundation may at any time, by written notice served to the Supplier, alter, or amend the contract for any identified need/requirement. The bidder shall not make any change until and unless READ Foundation has allowed the said change, by written order served on the Supplier. The Change, mutually agreed upon, shall constitute part of the obligations under the Contract, and the provisions of the Contract shall apply to the said change. No variation or modification in the Contract shall be made, except by written amendment signed by both READ Foundation and the Supplier.

# Warranty/Guarantee:

All goods / furniture offered by the bidder must be under workmanship and quality Warranty for a period of <a href="Mosestate"><u>05 Years</u></a> from the date of delivery. The successful bidder shall also provide Warranty Certificate on the Company's letterhead, signifying their responsibility for the product's quality.

#### **Dispute Resolution:**

In the case of a dispute between the Purchaser and the Supplier, a Dispute Resolution Committee shall be constituted by READ Foundation for the resolution of dispute. In case of non-resolution, the dispute shall be referred for adjudication or arbitration in accordance with Arbitration Laws of Pakistan and heard at Islamabad, the Capital Territory of Pakistan.

#### **Blacklisting:**

If the bidder fails/delays in performance of any of the obligations, under the Contract, violates any of the provisions of the Contract, commits breach of any of the terms and conditions of the Contract or found to have engaged in corrupt or fraudulent practices in competing for the award of contract or during the execution of the contract, READ Foundation may without prejudice to any other right of action / remedy it may have, blacklist the bidder, either indefinitely or for a stated period, for future. In such case, the Performance Guarantee / Bid Security of the bidder shall stands "forfeited".

#### **Payment Terms:**

The payments of the work will be released through cross cheque or online bank transfer (IBFT) to the firm after deduction of applicable govt. taxes in a reasonable time not exceeding fifteen (15) working days from the date of receipt of invoice after verification of the delivery and work done by our concerned site staff and Chief Engineer. Final payment terms and schedule will be decided between both parties (READ Foundation and the Successful Bidder) upon signing an agreement or award of Contract with mutual consent.

# **Bid Evaluation Criteria, Condition & Process:**

- **1.** Must register with tax authorities.
- 2. Initially, only the envelope marked "**Technical Bid**" shall be opened.
- **3.** Firms/Companies scoring **minimum 60% marks in the Technical Evaluation** will be qualified for Financial Evaluation.
- **4.** All those firms/companies blacklisted by any Govt. Department shall not be entertained.
- **5.** Conditional Quotations will not be accepted.
- **6.** Each paper of the bid document (alongwith this Tender Document) shall be stamped and signed by the authorized Signatory of the firm/company.
- 7. The Financial bids of the "Qualified" firms/companies will be opened and contract will be awarded. Financial Bids of bidders found technically "Non-Responsive" or "Not-Qualified" shall be returned unopened.

#### <u>Selection – Evaluation Process:</u>

- 1. An evaluation committee will review in detail all bids that are received to determine the extent to which they comply with Tender Document requirements, without reference to the price and reject any bid which does not conform to the specified requirements as listed in "Scope of Work / Annexure-D" section.
- 2. Financial bid will be checked only if a bid is determined to be otherwise qualified. The envelope marked as "Financial Bid" shall be opened in front of Procurement Committee members and the representatives of Qualified Bidders who may like to attend the meeting at a date, time and venue announced and communicated in advance.
- **3.** Overall evaluation shall be carried out based on weighted average methodology wherein Technical Evaluation will carry 40% and Financial Evaluation will carry 60% weightage respectively.

## **Combined Score:**

**Technical Score** = Total Secured Marks in all Technical Categories / 100 x 40

**Financial Score** = Lowest Financial Bid / Bidder's Financial Bid x 60
